

AFFIDAVIT

I, the undersigned PROF. DesiréDubounet(also known asWilliam Charles Nelson, having my current address at Kalvariater 2, H-1089 Budapest, Hungary, born in Warren, USA on June 19th 1951, mother's maiden name: Helen Tuori), a retired US alternative medicine practitioner (the "Affiant")
